Two-Days Training Programme on "NBC 2016 and Glass & Glazing System in Buildings" (July 17-18, 2017)

Architectural Glass Panel (Asahi Glass, Gujarat Guardian, HNG Glass & Gold Plus) / AIGMF alongwith other glass manufacturers like Saint-Gobain are committed and making all efforts to propagate appropriate glass use, enhance energy conservation performance, lighting, hygiene and functionability and ensure human and fire safety. In this endeavour the contribution and efforts of Confederation of Construction Products and Services

(CCPS) are appreciable. Regulatory bodies and major Govt. construction departments like CPWD, Govt. of Andhra Pradesh, Govt. of Rajasthan, NBCC, Airport Authority of India, MES, PWD's of Delhi, Haryana etc. have mandated and implemented the recommendation of CCPS "Guidelines on Use of Glass in Buildings: Human Safety".

Recently revised National Building Code 2016 was released in March 2017 and for the first time a new

section on Glass and Glazing was included in the document. To acquaint and update engineers, architects and professionals particularly from Government sector about requirements for ensuring safe and appropriate glass use in buildings as per NBC 2016, IS 16231 and CCPS Guidelines continuous efforts are being made, therefore, Two-Days Training Programme on "NBC 2016 and Glass & Glazing System in Buildings", was organized by CCPS, in collaboration with Indian Buildings Congress (IBC) on July 17 -18, 2017 at IBC (HQ), R. K. Puram, New Delhi.

The program was inaugurated by Mr. Sanjay Pant, HoD, CED, BIS on July 17th and certificates were distributed by Brig. Girish Joshi, DDGW (Design), MES at Valedictory Session on July 18th.



The programme was participated and attended by 44 senior officers and dignitaries from, Military Engineering Services, Central PWD, Bureau of Indian Standards, PWD Delhi Govt., PWD Gwalior MP, North Municipal Corporation of Delhi, PWD Rajasthan, MMRDA Mumbai, Schueco India, Dhruv Consultancy, Samrat Ashok Technology Institute Vidisha, M. P., Lingaya University, Faridabad and Amity University.

Concerned Departments of Central & State Governments., Development Authorities, Local Bodies, PSUs, prominent architects, consultants were approached by CCPS to take necessary action in propagation, implementation and inclusion in Building **Byelaws** the relevant recommendations of NBC 2016 to ensure human and fire safety while using glass in buildings and the gist of recommendations was widely Article "Revised circulated. on National Building Code of India 2016 equipped with a new Section on Glass and Glazing" was published in Kanch April-June 2017 issue highlighting the advisory clauses for safety against glass impact, manifestation, ease of carrying out fire fighting and rescue operations etc. Many Departments, Local Bodies, Development Authorities have started considering recommendations of NBC 2016 for implementation. Recently Notification - Chandigarh Building Rules (Urban) -2017 have been uploaded on July 27, 2017 by Chandigarh Administration and order dated August 25, 2017 was also issued by MES .
